Rx Edit performs a series of pre and post edits as claims are routed through the switch to optimize them for compliance and reimbursement.

Rx Edit helps you achieve audit and regulatory compliance by:

- Verifying prescriber identifiers
- Confirming DEA numbers and flagging claims where the DEA has been expired for more than 30 days, or is invalid
- Validating prescriber eligibility for Medicare Part D
- Identify inappropriate DAW values that could lead to under-reimbursement or audit risks
- Evaluating commonly audited products for specific fields such as day supply, new prescription requirements, and date written

Our solution helps you optimize reimbursement on each claim by:

- Checking and automatically updating the ingredient-cost field
- Identifying inappropriate quantities for products dispensed as milliliters, grams, or total packs, with suggested proper pack sizes
- Rejecting claims with an NDC discontinued for more than 181 days
- Detecting suspect DAW combinations of products

On the claim's return, a series of post edits are performed with specific messaging added to the claim response for review, e.g., if a claim needs to be updated to reflect a new U&C rate.

By providing clear messaging on suspected issues along with suggested actions, our solution enables you to optimize the accuracy of each claim prior to submitting it to the payer, and you retain the ability to override any suggestion.

Additional benefits

You will also have access to:

- A secure portal to view comprehensive reports, such as trends on drug pricing and the pharmacy's use of overrides on suggested claim edits
- A claim resubmission service to identify, reverse, and resubmit claims that were adjudicated using outdated average wholesale pricing (AWP)
